PRESS RELEASE

The New Jersey State Police, the Warren County Prosecutor's Office and the Phillipsburg Police Department, executed a search warrant on February 19, 2022 at 81 Broad Street in Phillipsburg, New Jersey. The search warrant was part of four week on-going investigation into the distribution of illegal narcotics in the Phillipsburg Area.

During execution of the search warrant police recovered:

- (6) semi automatic handguns of various make/caliber (3 ghost guns / 1 defaced)
- Ammo container with .223 ammunition, several boxes of various caliber hollow point ammunition, shotgun shells, multiple high capacity magazines, and a 12 gauge drum magazine
- \$7,360.00 in US Currency
- 137 grams of Cocaine w/ approximate value of \$8,905.00
- 16 lbs. Marijuana w/ approximate value of \$32,000.00
- (1) vial PCP, Oxycodone, Xanax, and Alprazolam

The adults were who present were taken into custody and charged. Two juveniles who were present were released to their parents. The adults were charged as follows:

- 1. One count of Conspiracy/Unlawful Possession of Weapons (Handgun) 2C:5-2/ 2C:39-5b. Second Degree. Each second degree charge carries up to ten (10) years New Jersey State Prison.
- 2. One Count of Conspiracy to Possess Controlled Dangerous Substance 2C:5-2/ 2C:35-10(a). Third Degree. Each third degree charge carries up to five (5) years New Jersey State Prison.
