Following a six-week investigation into the distribution of CDS in the Township of Washington, Cortney Deremer and Alonzo Widenor were arrested by members of the Warren County Prosecutor's Office Narcotics Task Force on Heroin and Methamphetamine charges. This investigation was conducted by the Warren County Prosecutor's Office Narcotics Task Force with the assistance of the Washington Township Police Department, Hackettstown Police Department and the New Jersey State Police.

Cortney Deremer was charged with the following offenses and released on a complaint summons pending a future court hearing:

- 1. Two (2) counts of Distribution of CDS (Methamphetamines), a third degree offense in violation of N.J.S.A. 2C:35-5B(3). Third Degree offenses carry a maximum of five years New Jersey State Prison.
- 2. Three (3) counts of Possession with Intent to Distribute CDS (Methamphetamines and Heroin), a third degree offense in violation of N.J.S.A. 2C:35-5B(3). Third Degree offenses carry a maximum of five years New Jersey State Prison.
- 3. One (1) count of Possession with Intent to Distribute CDS (Methamphetamines) within 1,000 feet of a School Zone, a third degree offense in violation of N.J.S.A. 2C:35-7A. Third Degree offenses carry a maximum of five years New Jersey State Prison.

Alonzo Widenor was charged with the following offenses and released on a complaint summons pending a future court hearing:

- 1. One (1) count of Possession of CDS (Methamphetamines), a third degree offense in violation of N.J.S.A. 2C:35-10A(1). Third Degree offenses carry a maximum of five years New Jersey State Prison.
- 2. One (1) count of Possession of CDS (Heroin), a third degree offense in violation of N.J.S.A. 2C:35-10A(1). Third Degree offenses carry a maximum of five years New Jersey State Prison.

The Defendants are presumed innocent unless and until proven guilty.
