GABRIEL C. TULLO-MCVICAR GLEN GARDNER, NEW JERSEY

AGE: 27

During the month of October an investigation into stolen property was initiated. During the investigation, Gabriel Tullo-McVicar was identified as a suspect for possession of several stolen firearms.

After further investigation, on October 10, 2025, Tullo-McVicar was arrested for the illegal sale of seven (7) firearms. Additionally, he was found to be in the possession of methamphetamine. Tullo-McVicar was arrested, processed, and lodged in the Warren County Correctional Center.

As a result of this investigation, a total of fifteen (15) firearms have been seized and removed from the community. This investigation reflects our commitment to making our communities safer by removing illegal firearms from circulation.

Tullo-McVicar was charged on complaint warrants with the below offenses.

- 1. Possession of a Controlled Dangerous Substance, in violation of <u>N.J.S.A.</u> 2C:35-10a(1), a crime of the third degree;
- 2. Possession of a Firearm while possessing a Controlled Dangerous Substance, in violation of N.J.S.A. 2C:39-4.1a, a crime of the second degree;
- 3. (3 counts) Possession of a Weapon for an Unlawful Purpose, in violation of N.J.S.A. 2C:39-4a(1), a crime of the second degree;
- 4. Illegal Transportation and Sale of Defaced Firearms, in violation of <u>N.J.S.A.</u> 2C:39-9m, a crime of the second degree;
- 5. (2counts) Unlawful Possession of a Firearm, in violation of N.J.S.A. 2C:39-5c(1), a crime of the third degree;
- 6. (2 counts) Possession of Stolen Property, two (2) shotguns and one (1) Sig Sauer handgun, in violation of N.J.S.A. 2C:20-7a, a crime of the third degree;
- 7. Unlawful Possession of a Weapon, specifically a stolen handgun, without first obtaining a permit, in violation of N.J.S.A. 2C:39-5B(1), a crime of the second degree.

Second degree crimes carry a maximum sentence of ten (10) years in the New Jersey State Prison and third degree crimes carry a maximum sentence of five (5) years in the New Jersey State Prison.

The charges are merely accusations. The defendant is presumed innocent until and unless proven guilty beyond a reasonable doubt in a court of law.

The investigation was conducted by the Warren County Prosecutor's Office, and the Washington Township Police Department. Assisting with the investigation was the Hunterdon County Prosecutor's Office, the Warren County Tactical Response Team, and the New Jersey State Police Washington Barracks.
