Following a seven-week investigation into the distribution of methamphetamine in the Township of Greenwich, the Warren County Prosecutor's Office Narcotics Task Force and the Greenwich Township Police charged the above defendants with multiple narcotics related offenses.


Michael Lovering was charged with the following:

- 1) Two counts Distribution of methamphetamine, a third-degree offense in violation of N.J.S.A 2C:35-5B(9)(B), a third degree offense. Each offense carries a maximum of (5) five years in New Jersey State Prison and up to a \$35,000.00 fine.
- 2) Two counts Possession with intent to distribute methamphetamine, a third-degree offense in violation of N.J.S.A 2C:35-5B(9)(B), a third degree offense. Each offense carries a maximum of (5) five years in New Jersey State Prison and up to a \$35,000.00 fine.
- 3) One count Possession of methamphetamine, a third-degree offense in violation of N.J.S.A 2C:35-10(A)1, a third degree offense. Each offense carries a maximum of (5) five years in New Jersey State Prison and up to a \$35,000.00 fine.
- 4) One count Possession of Drug Paraphernalia, N.J.S.A. 2C: 36-2 a disorderly person's offense.

Jade Ike was charged with the following:

- 1) One count Possession of heroin, a third-degree offense in violation of N.J.S.A. 2C:35-10(A)1, a third degree offense. Each offense carries a maximum of (5) five years in New Jersey State Prison and up to a \$35,000.00 fine.
- 2) One count Possession of Drug Paraphernalia, N.J.S.A. 2C: 36-2 a disorderly person's offense.

Please be advised that the charges are merely accusations and that the defendants are presumed innocent unless proven guilty in a court of law.
