CHARGED: John Nunn

On February 6, 2022, just after 2:00 AM the above referenced individual recklessly operated his motor vehicle causing it to strike a home in Washington, New Jersey. Just prior to the accident, Nunn passed two cars at a high rate of speed, lost control of the vehicle and left the roadway. He then hit a landscaping feature causing his vehicle to go airborne before crashing through the second floor bedroom of a private residence where one of the victims slept. As a result of his conduct, one person died and another remains severely injured. The investigation revealed that his Blood Alcohol Content was .118 at the time of the blood draw which was at 7:15 A.M. Additionally, Nunn was determined to be driving in excess of 100 M.P.H. based on Crash Data retrieval information downloaded from the vehicle. The Warren County Prosecutor's Office and Washington Township Police Department investigated the accident, with assistance from countless neighboring agencies who responded that night.


On March 11, 2022 John Nunn was charged with the following offenses;

- (1) One count of N.J.S.A. 2C:11-4(a)(1)(Aggravated Manslaughter)(First Degree). This charge carries a maximum penalty of up to thirty (30) years New Jersey State Prison.
- (2) One count of N.J.S.A. 2C:11-5(a)(Death by Auto)(Second Degree). A second degree crime. Second degree crimes carry a maximum penalty of up to ten (10) years New Jersey State Prison.
- (3) One count of N.J.S.A. 2C:12-1(b)(1)(Aggravated Assault) (Second Degree). A second degree crime. Second degree crimes carry a maximum penalty of up to ten (10) years New Jersey State Prison.
- (4) One count of N.J.S.A. 2C:12-1(c)(3)(Assault by Auto) (Third Degree). Third degree offenses carry up to five (5) years New Jersey State Prison.

(5) One count of N.J.S.A. 2C:12-1(b)(3)(Aggravated Assault) (Fourth Degree). Fourth degree offenses carry up to eighteen (18) months New Jersey State Prison.

Washington Township Police had previously issued motor vehicle summons for Driving While Intoxicated, Reckless Driving and related offenses.

Please be advised that the charges are merely accusations and the defendant is presumed innocent until and unless proven guilty.
